**Doctoral Educational Program
«8D03115 – International Relations»**

1. Name of the program: Doctoral educational program «8D03115 – International Relations» (direction of training «8D031 - Social Sciences»).

2. Study period: 3 years

3. Total credits (ECTS): 185

4. Description of the program:

The program is aimed to train highly qualified specialists in conducting independent comprehensive scientific research on a contemporary topic of International Relations based on the study of modern international theories and methods of foreign policy analysis.

The program is based on strategic documents defining the priorities of the foreign policy of the Republic of Kazakhstan, namely the Development Strategy of the Republic of Kazakhstan until 2050 and the Concept of the Foreign Policy of the Republic of Kazakhstan for 2020–2030.

The curriculum of the program is adapted to modern realities and is focused on conducting students' independent research work. The program combines the systemic development of successful world practice in the development of the public administration system in the field of Foreign Policy and International Relations with the capabilities of research tools.

5. Purpose and objectives of the program:

Aim: Train highly qualified specialists in carrying out effective research and professional management activities in the field of Foreign Policy and International Relations.

Objectives of the program:

1) to teach the effective use of modern research methods for analyzing the development of processes in the system of International Relations, assessing and predicting their impact on the Republic of Kazakhstan;

2) to develop professional competencies of civil servants for the effective implementation of government policy in the field of International Relations;

3) to develop research competencies for conducting scientific research focused on solving topical issues in the field of Foreign Policy and International Relations with the possibility of introducing its results into the practice of state bodies.

6. Benefits of the program:

- practice-oriented disciplines with a specialization for improving the level of professional training of specialists using modern teaching methods;

- carrying out research work (*dissertation*), which is focused on solving modern foreign policy problems of the Republic of Kazakhstan, under the scientific guidance of recognized international experts and experienced practitioners;

- development of research potential - the study of research methods and design, undergoing a research-based practical training;

- involvement in lectures / workshops of invited specialists on modern issues of international relations and foreign policy of the Republic of Kazakhstan, participation in international forums and conferences;

- classes are conducted in three languages: Kazakh, Russian and English.

The implementation partner of the program is the Ministry of Foreign Affairs of the Republic of Kazakhstan.

Foreign Partners: Diplomatic Academy in Vienna (the Diplomatische Akademie Wien - Vienna School of International Studies); Diplomatic the Emirates Diplomatic Academy and other leading diplomatic schools.

7. Expected learning outcomes:

Formation / development of competencies:

1) Strategic Thinking / System Management – planning, predicting and making long-term decisions for the sustainable development of a governmental body, while taking into account future scenarios of possible consequences and risks; being able to effectively manage and control processes and resources (*material, financial, human, etc.*) by making consistent decisions that contribute to the achievement of the strategic goals of a government body with the lowest expenses and in the shortest time period.

2) Leadership and Emotional Intelligence - inspires and engages employees to effectively achieve the goals of the government agency, including by their own example; recognizes emotions, understands the intentions, motivations and desires of others and his/her own, and also manages his/her emotions and the emotions of others in order to solve practical problems.

3) Cooperation and Interaction - builds constructive relationships with colleagues, other government agencies and organizations to achieve the strategic goals of the government agency.

4) Analysis and Decision Making – analyzing quantitative, verbal and other forms of information; considering an individual task or problem as a part of the whole process, while taking into account all the connections; being able to comprehensively assess a situation (*information*) and adopt an optimal and timely decision.

5) Innovativeness and Change Management - develops innovative approaches, finds original solutions, offers several options for action, calls into question the established ideas; effectively implements change, including through the application of a structured approach to preparation, education and support of employees.

6) Initiableness and Creativeness - generates new ideas aimed at improving performance; deviates from traditional thinking patterns, can find non-ordinary ways and approaches in solving complex issues, is directly involved in changing the surrounding reality.

7) Digital Thinking – uses digital resources in professional activities to increase its efficiency, with the help of digital means finds ways of development and ways to solve problems.

8) Technological Awareness – staying up to date with current technological trends and developments; being able to apply modern technological tools in professional activities.

9) Tolerance/Respect Towards Diversity – respecting principles of cultural and religious diversity; being able to adapt properly to a foreign environment.

Study methods, forms, technologies: discussion and debates, games, team teaching, case-study, blended learning, group quizzes, mind mapping, host debates, problem essay, brainstorming, in-basket, interactive workshops, situational analysis.
