- **1. Name of the program**: Educational programme of doctoral studies «8D03115 International Relations» (*training direction «8D031 Social Sciences»*).
 - **2. Term of study**: 3 years **3. Total credits** (*ECTS*): 180
 - 4. Program description:

The programme is aimed at training highly qualified specialists capable of conducting independent scientific research in the field of international relations on the basis of systematic and in-depth mastering of methods of applied analysis and research activities.

The programme involves a combined study of modern international theories and concepts, topical issues of politics and security, as well as foreign policy priorities and national interests of the Republic of Kazakhstan.

The programme is based on the strategic documents defining the priorities of the state's foreign policy - the Development Strategy of the Republic of Kazakhstan until 2050 and the Foreign Policy Concept of the Republic of Kazakhstan for 2020-2030.

5. Aim and objectives of the program:

Objective: to produce cutting-edge expert researchers in the field of international relations. *Objectives of the Programme:*

- to develop research competences for conducting scientific research oriented to the solution of actual foreign policy of Kazakhstan with the possibility of introducing its results into the practice of state bodies;
- To provide a thorough and detailed understanding of current international processes, as well as the role and place of Kazakhstan in regional and international politics.
