**1. Name of the program:** Doctoral Degree Program «8D03115 – International Relations» (training area «8D031 – Social sciences»).

**2. Term of study:** 3 years

**3. Total credits (ECTS):** 180

**4. Program description:**

The program is aimed at training highly qualified specialists capable of conducting independent scientific research in the field of international relations on the basis of systematic and in-depth mastering of methods of applied analysis and research activities. Doctoral students receive fundamental methodological and research training. The educational program includes theoretical, practical and research training.

The program involves a combined study of modern international theories and concepts, topical issues of politics and security, and the Republic of Kazakhstan's foreign policy priorities and national interests.

The program is based on strategic documents that determine the priorities of the state's foreign policy - the Development Strategy of the Republic of Kazakhstan until 2050 and the Foreign Policy Concept of the Republic of Kazakhstan for 2020-2030.

**5. Aim and objectives of the program:**

*Purpose:* training of leading research experts in the field of international relations.

*Program objectives:*

- to develop research competencies for conducting scientific research focused on solving the current foreign policy of Kazakhstan with the possibility of implementing its results in the practice of state bodies;
- to give a deep and detailed understanding of current international processes, as well as the role and place of Kazakhstan in regional and international politics.

**6. Benefits of the program:**

1) practice-oriented disciplines in the specialty to improve the level of professional training of specialists using modern teaching methods;

2) implementation of research work (*dissertation*) focused on solving topical problems of the foreign policy of the Republic of Kazakhstan under the scientific supervision of recognized international experts and experienced practitioners;

3) development of research potential – study of research methods and design, research practice;

4) participation in lectures and workshops by invited experts on topical issues of international relations and foreign policy of the Republic of Kazakhstan, participation in international forums and conferences;

5) teaching disciplines in three languages: Kazakh, Russian, and English.

The partner in the implementation of the program is the Ministry of Foreign Affairs of the Republic of Kazakhstan.

**7. Expected learning outcomes:**
